
"Committed to the Heart" Goals:

- Increase education on effective AED use.
- Increase bystander CPR readiness at the community level.
- Improve out-of-hospital sudden cardiac arrest survival rates, meaning, survived to discharge, among those CAH communities who are CARES (Cardiac Arrest Registry to Enhance Survival) Medical Centers.



"Committed to the Heart" Activities:


- Develop an internal plan to roll out CARES to 26 CAH communities and assist them with developing their own implementation plans
- Determine how many public AED's are listed on the National AED Registry and assist with registering unlisted devices and offer AED instruction at those locations
- Use CARES data to determine times and locations of Out of Hospital Cardiac Arrest events as well as which elements of response system properly functions
- Complete an assessment on bystander readiness within the CAH communities and offer CPR Classes

 "Committed to the Heart" will primarily focus on the 26 Kentucky counties with a CAH. There also could be an overlap into adjacent counties. CARES will be a statewide rollout to all EMS and Hospitals in Kentucky

Project Description

The New Mexico project involves enhanced training, technical assistance and consultation of rural Emergency Medical Service (EMS) personnel, and training of rural EMS managers and Medical Directors.

Through this project, it will improve the accuracy of patient care reports and quality of patient care performance that are submitted into the New Mexico EMS Tracking and Reporting System (EMSTARS), which will provide accurate and meaningful data reports for Quality Improvement for rural New Mexicans.





 Improve the accuracy of data input into the state's EMS data system and the ability of EMS services to generate accurate and meaningful individual and state reports.

 Improve the Quality Improvement (QI) process by using data collected to improve the quality of patient care.


